Terms and conditions for shipping orders

Exchange of pallets, etc.

If pallets are not exchanged when the goods are collected, they must be returned within 5 working days. If pallets are not exchanged at the consignee's premises, we must be advised within 24 hours; otherwise, we will be unable to maintain pallet levels and will have to charge the contractor EUR 13 per Euro pallet/half pallet and EUR 90 per box pallet plus VAT.

Customer protection

Customer protection is deemed to be agreed, and in the event of noncompliance on the part of the contractor or an authorized handler you will be liable to recourse to the sum of EUR 2,500. Contractors accepting the goods do so in the name of and on behalf of Dorfner.

Charging

Freight costs are only payable on receipt of the original copies of the signed CMR note and delivery note. If these documents are not received by Dorfner within 8 working days, Dorfner reserves the right to reduce the freight costs by EUR 25 per load to cover the increased administration costs. The assignment of any claim arising out of this order, e.g. to a factoring company, is strictly excluded (section 399 of the German Civil Code, BGB).

Insurance cover

The contractor will provide insurance cover as required in respect of the CMR/GüKG [German Road Haulage Act]/HGB [German Commercial Code]/VBGL [Terms of Contract for Road Haulage and Logistics Companies]; notwithstanding section 431 HGB, a maxmum liper kg is agreed for damage to the other duties described above goods.

Delivery adherence

This shipping order assumes adherence to collection and delivery times and dates. If any truck or loading space booked by Dorfner is not provided, Dorfner will procure a replacement and charge additional costs thus incurred to the contractor.

Demurrage

Unless otherwise agreed, demurrage will not be paid for collections and deliveries.

Bulk loads

Residues in tankers and hoses must be cleaned/rinsed out.

Agreement on compliance with section 7c GüKG transport management requirements

The contractor confirms that it holds the permits and authorizations required for transporting goods in accordance with Sections 3 and 6 of the GüKG (i.e. permit, Euro license, third-country approval and CEMT approval). The contractor undertakes to use only third-country foreign drivers who hold the necessary work permit and moreover to ensure that foreign drivers hold and can produce As of: 11.12.2013 official certification accompanied by officially certified German translation in section 7b (1) sentence 2 GüKG on every journey. The undertakes to fulfill this duty with re-

ability of 40 special drawing rights gard to producing documents and in respect of its subcontractors. The contractor undertakes to use only freight carriers who meet the requirements of section 7b GüKG and to monitor them.

Security declaration for Authorized Economic Operators (AEOs)

The contractor confirms that the goods which are the subject of this

- c) that the personnel assigned to this order are reliable.
